
BUTLER COURT

CAPTION:

Commence at a Permanent Reference Monument at the Northeasterly corner of said Block 6 for point of beginning and run thence S 0°-26'W, along the Easterly Boundary thereof, 250 feet to a Permanent Reference Monument, run thence S. 89°-36'W and parallel to the Southerly Boundary of said Block 6, 110' to an Iron stake, run thence S 0°-26W and parallel to said Easterly Boundary 84 feet to an iron stake, run thence N 89°-36'E and parallel to said Southerly Boundary, 110 feet to said Easterly Boundary; run thence SO°-26'W along said Easterly Boundary, 84 feet to the Southeasterly corner of said Block 6; run Thence \$ 89°-36'W, along said Southerly Boundary, 418 feet to the Southwesterly corner of said Block 6; run thence N 0°-26'E along the Westerly Boundary Thereof 418 feet to the Northwesterly corner of said Block 6; run thence N 89°-36'E along the Northerly Boundary thereof 418' to point of beginning.
