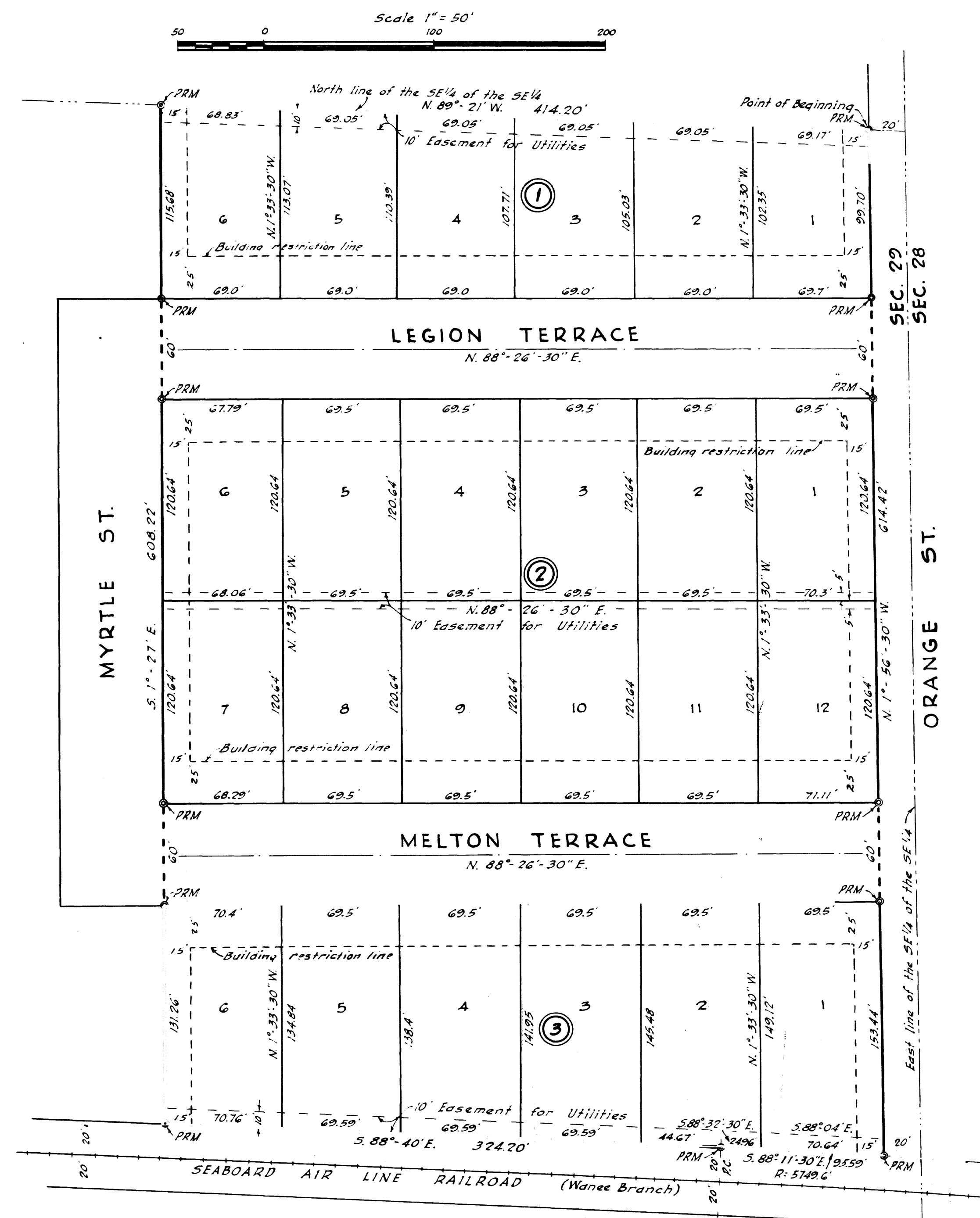


# HARDY'S ADDITION

STARKE, BRADFORD COUNTY, FLORIDA

A SUBDIVISION OF A PORTION OF THE SE 1/4 OF THE SE 1/4 OF SECTION 29 TOWNSHIP 6 SOUTH, RANGE 22 EAST, MORE PARTICULARLY DESCRIBED IN THE CAPTION



**CAPTION:**  
 For point of reference commence at the Northeast corner of the Southeast Quarter of the Southeast Quarter of Section 29, Township 6 South, Range 22 East, Bradford County, Florida, and run North eighty-nine degrees twenty-one minutes West (N. 89° 21' W.) a distance of 414.20' to a permanent reference monument for the point of beginning.  
 From the point of beginning thus described continue North eighty-nine degrees twenty-one minutes West (N. 89° 21' W.) along the Northerly boundary line of the Southeast Quarter of the Southeast Quarter of said Section 29, a distance of four hundred fourteen and two tenths (414.2) feet to a permanent reference monument; run thence South one degree twenty-seven minutes East (S. 1° 27' E.) a distance of six hundred eight and twenty-two hundredths (608.22) feet to a permanent reference monument located on the Northerly boundary line of the Seaboard Air Line Railroad (Wanee Branch) right-of-way; run thence South eighty-eight degrees forty minutes East (S. 88° 40' E.) along the Northerly boundary line of said right-of-way a distance of three hundred twenty-four and two tenths (324.2) feet to a permanent reference monument located at a point of curvature in said boundary line; continue thence Easterly along the Northerly boundary line of said right-of-way and along the arc of a curve concave to the South and having a radius of five thousand seven hundred forty-nine and six tenths (5749.6) feet a chord distance of ninety-five and fifty-nine hundredths (95.59) feet to a permanent reference monument located on the Northerly boundary line of said Railroad right-of-way where said Northerly boundary line is intersected by a line parallel to and twenty (20) feet Westerly from the Easterly boundary line of the Southeast Quarter of the Southeast Quarter of Section 29 aforementioned, when measured at right angles thereto, the bearing of said chord being South eighty-eight degrees eleven minutes thirty seconds East (S. 88° 11' 30" E.); run thence North one degree fifty-six minutes thirty seconds West (N. 1° 56' 30" W.) keeping parallel to and distant twenty (20) feet Westerly from the Easterly boundary line of the Southeast Quarter of the Southeast Quarter of said Section 29, when measured at right angles thereto, a distance of six hundred fourteen and forty-two hundredths (614.42) feet to the point of beginning.

 Bearings and distances shown on curves refer to the chord.
