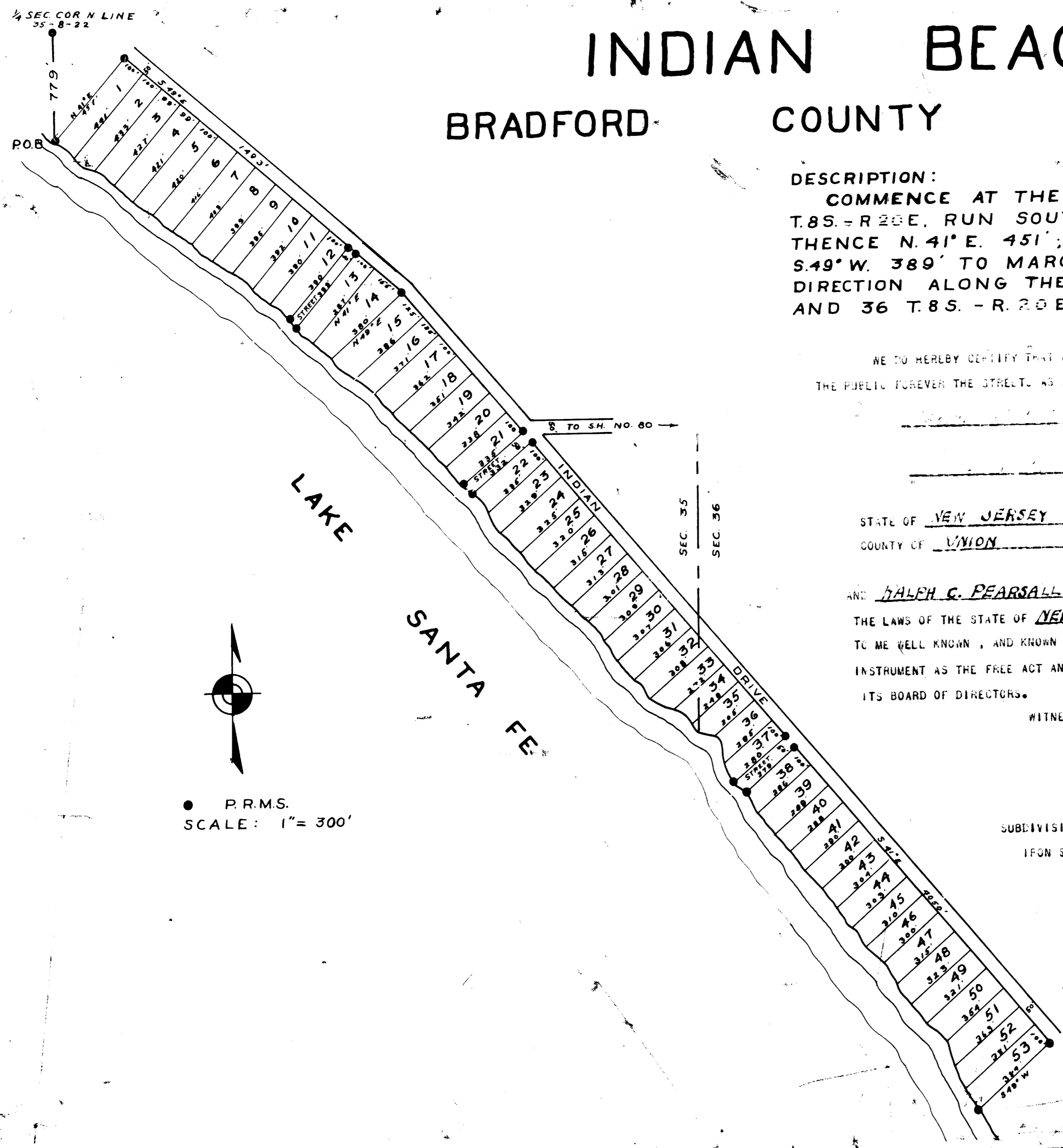


# INDIAN BEACH

THENCE N. 41° E. 451'; THENCE S. 49° E. 1493'; THENCE S. 41° E. 4050' THENCE S. 49° W. 389' TO MARGIN OF LAKE SANTA FE, THENCE IN A NORTHWESTERLY DIRECTION ALONG THE LAKE MARGIN TO P.O.B. ALL BEING IN SECTIONS 35 AND 36 T.8S. - R. 20E.
