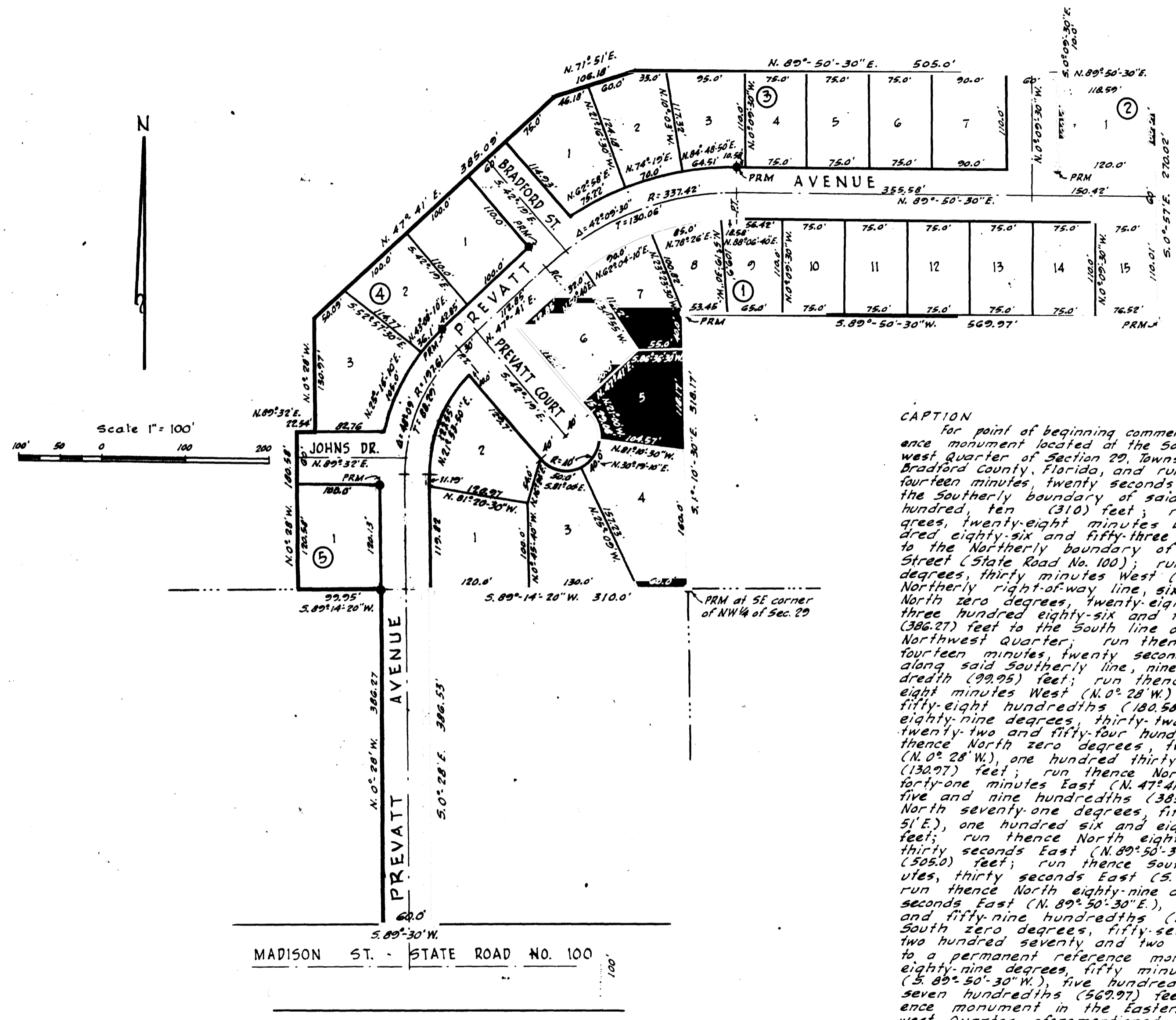


**SARATOGA HEIGHTS UNIT ONE BOOK 2 PAGE 64**

A SUBDIVISION OF A PORTION OF THE NW 1/4; A PORTION OF THE S 1/2 OF THE NE 1/4;  
 AND A PORTION OF THE NE 1/4 OF THE SW 1/4 OF SECTION 29, TOWNSHIP 6 SOUTH, RANGE  
 22 EAST. THE LANDS HEREBY SUBDIVIDED BEING MORE PARTICULARLY DESCRIBED BELOW



**CAPTION**  
 For point of beginning commence at a permanent reference monument located at the Southeast corner of the Northwest Quarter of Section 29, Township 6 South, Range 22 East, Bradford County, Florida, and run South eighty-nine degrees, fourteen minutes, twenty seconds West (5.89° 14' 20" W) along the southerly boundary of said Northwest Quarter, three hundred, ten (310) feet; run thence South zero degrees, twenty-eight minutes East (5.0° 28' E), three hundred eighty-six and fifty-three hundredths (386.93) feet to the Northerly boundary of the right-of-way of Madison Street (State Road No. 100); run thence South eighty-nine degrees, thirty minutes West (5.89° 30' W) along said Northerly right-of-way line, sixty (60) feet; run thence North zero degrees, twenty-eight minutes West (N.0° 28' W) three hundred eighty-six and twenty-seven hundredths (386.27) feet to the South line of the aforementioned Northwest Quarter; run thence South eighty-nine degrees, fourteen minutes, twenty seconds West (5.89° 14' 20" W) along said southerly line, ninety-nine and ninety-five hundredth (99.95) feet; run thence North zero degrees, twenty-eight minutes West (N.0° 28' W) one hundred eighty and fifty-eight hundredths (180.58) feet; run thence North eighty-nine degrees, thirty-two minutes East (N.89° 32' E) twenty-two and fifty-four hundredths (22.54) feet; run thence North zero degrees, twenty-eight minutes West (N.0° 28' W), one hundred thirty and ninety-seven hundredths (130.97) feet; run thence North forty-seven degrees, forty-one minutes East (N.47° 41' E), three hundred eighty-five and nine hundredths (385.09) feet; run thence North seventy-one degrees, fifty-one minutes East (N.71° 51' E), one hundred six and eighteen hundredths (106.18) feet; run thence North eighty-nine degrees, fifty minutes, thirty seconds East (N.89° 50' 30" E) five hundred five (505.0) feet; run thence South zero degrees, nine minutes, thirty seconds East (S.0° 09' 30" E), ten (10) feet; run thence North eighty-nine degrees, fifty minutes, thirty seconds East (N.89° 50' 30" E), one hundred eighteen and fifty-nine hundredths (118.59) feet; run thence South zero degrees, fifty-seven minutes East (S.0° 57' E) two hundred seventy and two hundredths (270.02) feet to a permanent reference monument; run thence South eighty-nine degrees, fifty minutes, thirty seconds West (S.89° 50' 30" W), five hundred sixty-nine and ninety-seven hundredths (569.97) feet to a permanent reference monument in the Easterly boundary of the Northwest Quarter aforementioned; run thence South one degree, ten minutes, thirty seconds East (S.1° 10' 30" E) along said Easterly boundary, three hundred, eighteen and seventeen hundredths (318.17) feet to the point of beginning.
